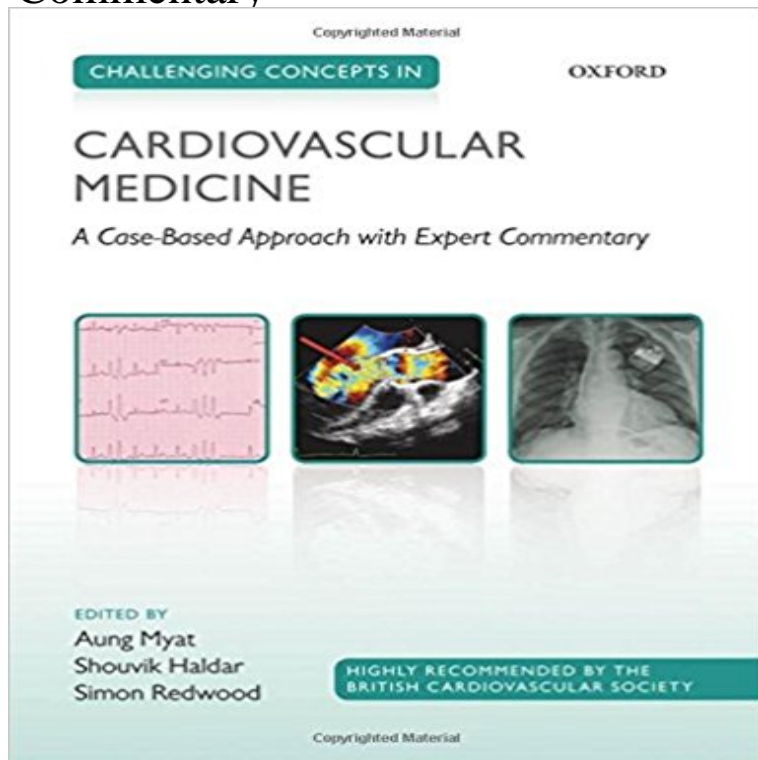


# Challenging Concepts in Cardiovascular Medicine: Cases with Expert Commentary
