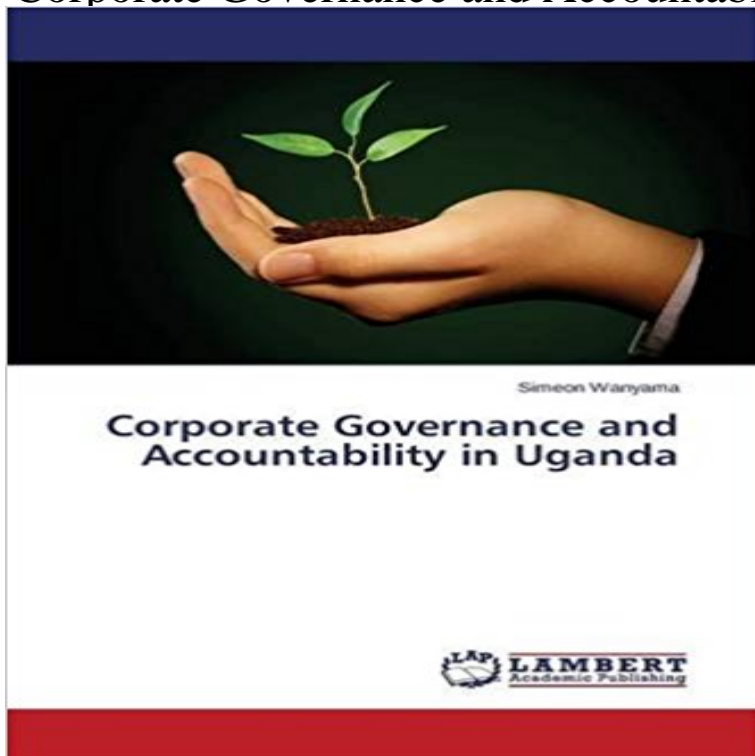


Corporate Governance and Accountability in Uganda
