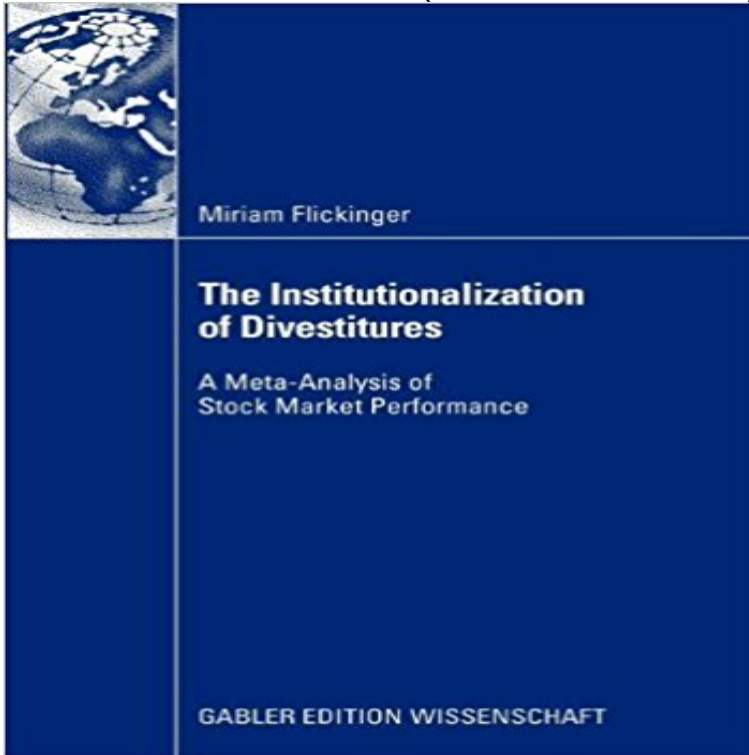


# The Institutionalization of Divestitures: A Meta-Analysis of Stock Market Performance (German Edition)



The theory of efficient capital markets, as proposed by finance scholars, contrasts daily experience suggesting that markets are not free of behavioral influences. The adoption of this finding into academic research has led to the development of the school of behavioral finance and has provided first institutional explanations for the behavior of market participants. Within this line of thought, market prices are interpreted also as socially determined events, allowing social explanations in addition to market and information efficiency to contribute to the forecast of market prices. The following thesis uses these insights and applies them to firms divestiture decisions. The work treats stock markets as social units where price formation is affected by institutional processes and is, therefore, guided by the logic established through them. Although the discussion on legitimacy and institutional processes has continued for many years within the organization and social sciences, its application to divestitures is new. The work, therefore, presents a novel contribution to a theory of firms boundaries in showing that processes of institutionalization play a part in divestiture decisions and their perception on the capital market. In doing so, the thesis also points out the necessity of integrating planned divestitures into existing social structures so as to prevent them from being perceived as illegitimate. Managers who take this necessity into account can help reduce business disturbances in spite of possibly far-reaching measures associated with a divestiture.
