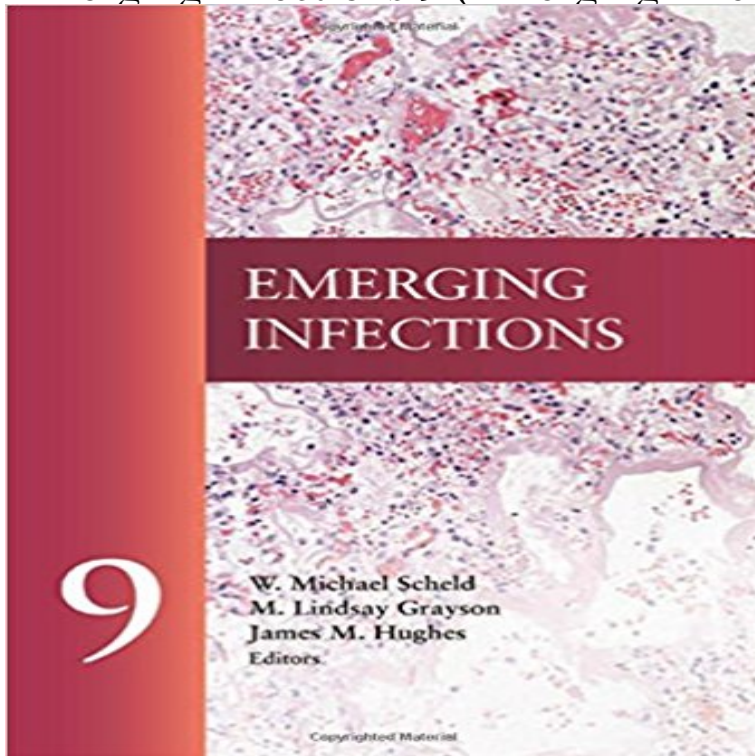


Emerging Infections 9 (Emerging Infections Series)
