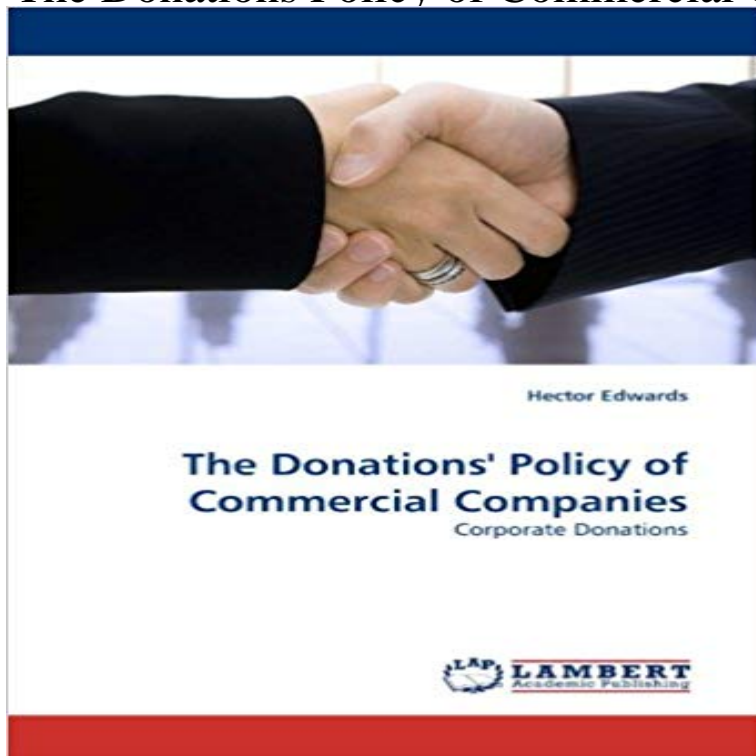


# The Donations Policy of Commercial Companies: Corporate Donations
