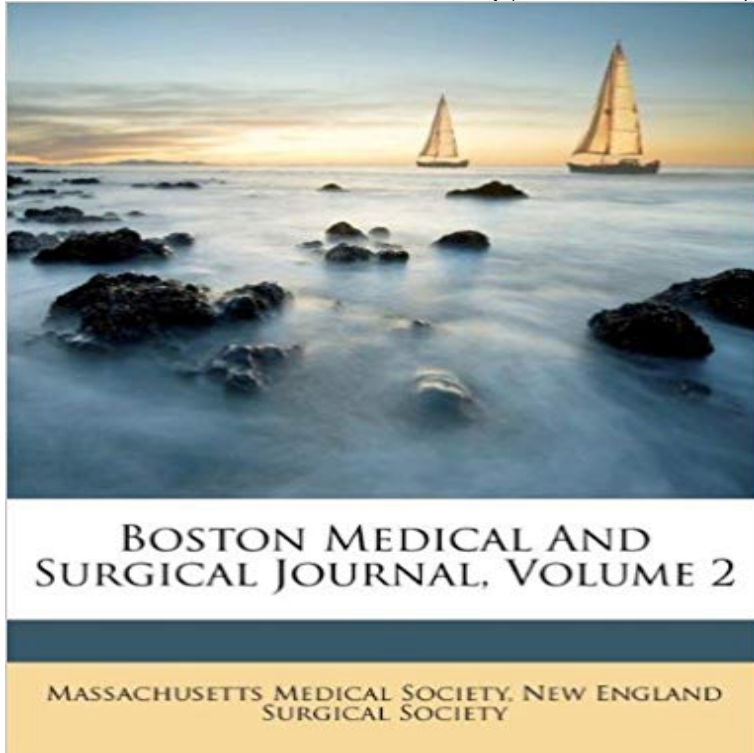


## Boston Medical And Surgical Journal, Volume 2
