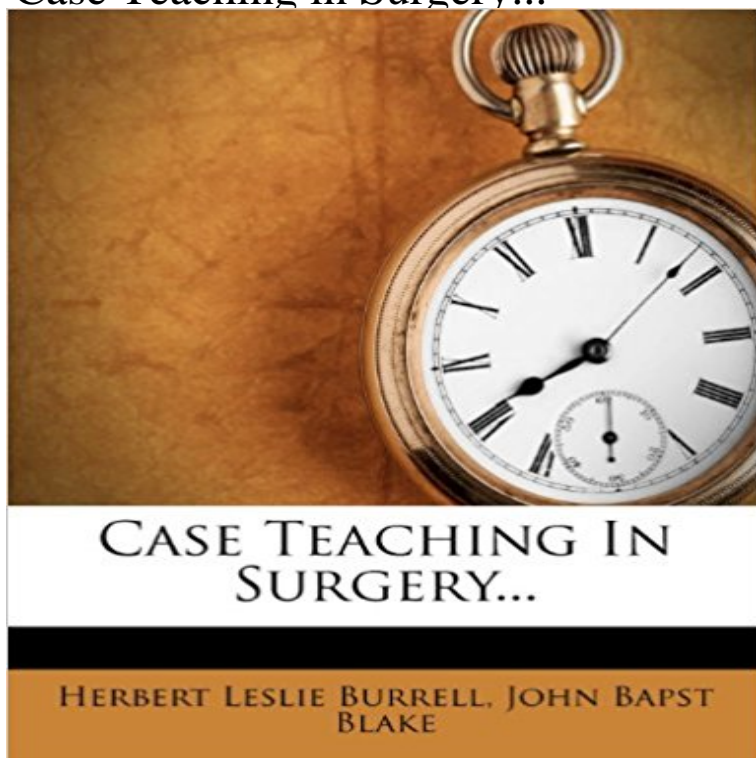


## Case Teaching in Surgery...
